The City of Beaverton is seeking sealed proposals from qualified licensed civil engineering firms, teams, or consultants, hereafter called Proposers, to provide professional engineering and design services for the Cooper Mt. Reservoir No. 2 and Associated Improvements. Consultants are invited to submit a proposal outlining their experience and qualifications in performing work directly related to the services required.

Sealed proposals will be received until 2:00 pm on 15 June, 2018, at the Finance Utility Billing Counter on the second floor of the Beaverton Building, City Hall at 12725 SW Millikan Way., Beaverton, Oregon 97005, Attention: Terry L. Muralt, CPPB, Purchasing Agent. There will be no formal opening. Facsimile proposals will not be accepted. Proposals will not be accepted after the stated opening date and time. Late proposals will be returned to the vendor unopened.

Additional questions that Proposers have during the procurement process will be accepted up to 5:00 PM June 8, 2018 and will be posted on the city's procurement website as Frequently Asked Questions.

Proposers are required to certify non-discrimination in employment practices in accordance with ORS 279A.110(4), and identify resident status as defined in ORS 279A.120(1). Pre-qualification of proposer is not required. All proposers are required to comply with the provisions of Oregon Revised Statutes and Beaverton's Contract Review Board Policy.

The City of Beaverton reserves the right (1) to reject any or all proposals not in compliance with public bidding procedures, 2) to postpone award of the contract for a period not to exceed ninety (90) days from date of proposal opening, (3) to waive informalities in the proposals, and (4) to select the proposal which appears to be in the best interest of the City.
