Summary of Application:	The applicant, Rembold Properties, requests approval for a New Conditional Use, Design Review Three, Replat One for Lot Consolidation, and a Sidewalk Design Modification by the Planning Commission for a mixed-use project. The proposed development will include 87 residential units, including 9 Live/Work units, and approximately 2,300 square feet of commercial space. Live/Work units are a conditional use in the RC-OT zoning district. The applicant has applied for a Sidewalk Design Modification for a reduction of ultimate sidewalk width to nine feet along SW Farmington Road.
Project Location:	The site is bounded by SW 1 st Street, SW Angel Street, SW Main Avenue, and SW Farmington Road. Tax Lots 1300, 1400, 1500, 1600, 1700, and 1800 on Washington County Tax Assessor's Map 1S116AD.
Zoning & NAC:	Regional Center-Old Town (RC-OT) / Central Beaverton NAC
Applicable Development Code Criteria:	Section 40.03 <i>Facilities Review</i> , Section 40.15.15.3.C <i>New Conditional Use</i> , Section 40.20.15.3.C <i>Design Review Three</i> , Section 40.45.15.2.C <i>Replat One</i> , and Section 40.58.15.C <i>Sidewalk Design Modification</i> .

The Facilities Review Committee is not a decision-making body, but advises the Director and Planning Commission on a project's conformity to the technical criteria specified in Section 40.03 of the Beaverton Development Code. The Director will include the Committee's recommendation in the staff report to the decision-making authority. The Facilities Review Committee meeting is open to the public, but is not intended for public testimony.
