Summary of Application:	The City proposes to amend the Beaverton Development Code to permit Food Cart Pods in certain Commercial, Industrial and Multiple-Use Zones. The proposal creates a new application type for Food Cart Pods as well as new standards to regulate Food Cart Pods. The update may affect all chapters of the Development Code.

If you decide to submit written comments or exhibits before the public hearing, all submittals prior to or at the hearing that are more than two (2) letter size pages must include no fewer than ten (10) complete copies of the materials being submitted.

You are receiving this notice to advise you of a proposed ordinance action. Section 50.50.2 of the Beaverton Development Code requires the City to provide written notice of a proposed ordinance action to the applicant, affected Neighborhood Association Committees (NACs), and owners of property within the City for which the proposed ordinance, if adopted, may in the Director's opinion affect the permissible uses of land. Property owner information is based on the most recent property tax assessment roll of the Washington County Department of Assessment and Taxation.

Staff reports are available for inspection at no cost a minimum of seven (7) calendar days before the public hearing. A copy of the staff report will be provided at a reasonable cost. Inspection or purchase of the staff report occurs at the Planning Division's Counter located in the Community Development Department on the 4th floor of the Beaverton Building, located at 12725 SW Millikan Way. Failure to raise an issue in a hearing, by testifying in person or by letter, or failure to provide statements or evidence with sufficient specificity to afford the decision-making authority an opportunity to respond to such issue, may preclude appeal to the Land Use Board of Appeals on that issue.
